Comment from Janet: There have been no recent new members. She would like to remind everyone that if one is mentoring someone, it is necessary to make an effort to do this.

Anne suggested that at each meeting we should highlight the duties of one of the board positions so that everyone would learn about them. This might widen the participation. Shelley said that we might highlight the definition of some term such as "consensus". with the same aim. Anne thought that this is a good idea since many of her friends have little political experience or knowledge even though they are smart and well informed.

Amanda said that she had talked to her intern advisor at WSU and suggested that

the League might give a 1/2 hour talk early in a Women's Studies course similar to the orientation which we are planning for our September meeting. Karen mentioned that this would have to be relevant to citizenship rather than just a recruiting talk. Otherwise WSU would have to allow other organizations to recruit.

Karen asked the board to consider whether we should write a letter to Dennis Tracy giving support to his "get out of jail" program. This program is a pre-charging diversion of first time offenders with clean records to enter the program and after successful completion of it they would be free with no police record. The board was in favor of writing such a letter if it would help. Karen will ask Dennis if such support is desired, and if so, Karen will draft a letter.
