OLD BUSINESS:

Valley Vision/Chamber Report

Commission discussed funding for Valley Vision (<u>https://lewis-clarkvalley.org</u>) and Whitman County Chambers. They approved \$2,000 for total funding: Whitman County Chambers' membership fees at the dues level for Palouse Chamber (\$25), Tekoa Chamber (\$75), Colfax Chamber (\$300), Roselia Chamber no longer exists, and for the Pullman Chamber (\$458 dues plus supplemented to the total of \$800). It was approved to support Valley Vision for \$800, lower than requested amount of \$2,000 because the Port of Wilma is the only Whitman County property that falls in the Valley Vision (Lewiston/Clarkston) region of support. Commissioner Meyer would like the Chambers and Valley Vision memberships "investment to be

relational" and to meet with them to hold them to a standard of service. Commissioner Webber thought it important to engage with the smaller organizations and help them get up to par.

FY 2020 SPRINT Challenge Grant – for technology-based economic development

"The City of Pullman submitted a grant application for the U.S. Economic Development Administration's FY 2020 Scaling Pandemic Resilience Through Innovation and Technology (Sprint) Challenge. ... Several of the activities included in the grant were envisioned with a physical meeting space in mind, so there is still opportunity for synergy between the Port, City, Washington State University and the Small Business Development Center. ... there has been discussion of convening of group of Port, City and university representatives to explore development around the gateway connecting WSU and downtown Pullman. Last week, Port staff attended a meeting where a landscape architecture professor presented some of his students' designs for this area surrounding the College Avenue Steam Plant in the year 2050."

Petrichor Update

Petrichor Broadband LLC is "continuing to keep the focus of getting urban levels of service (1 gig) at urban pricing to rural areas." Membership within this organization are impressed with Chief Operating Officer Riebold and Director Poire in their leadership role. RESOLUTION 20-26

A RESOLUTION ESTABLISHING GUIDELINES FOR MONETARY AND OTHER SUPPORT REQUESTS FOR TOURISM AND RECREATION DEVELOPMENT PROJECTS IN WHITMAN COUNTY

WHEREAS, the Port of Whitman County Commissioners recognize the value and benefit of tourism and recreation to Whitman County; and

WHEREAS, RCW 53.08.260 authorizes port districts to construct, improve, maintain, and operate public park and recreation facilities when such facilities are necessary to more fully utilize boat landings, harbors, wharves and piers, air, land, and water passenger and transfer terminals, waterways, and other port facilities authorized by law pursuant to the port's comprehensive plan of harbor improvements and industrial development; and

WHEREAS, RCW 53.08.255 authorizes port districts to expend moneys and conduct promotion of resources and facilities in the district or general area by advertising, publicizing, or otherwise distributing information to attract visitors and encourage tourist expansion; and

WHEREAS, the Commission wishes to rescind Resolution 03-03 pertaining to guidelines for monetary requests for tourism and recreation development projects in Whitman County and adopt a new guidelines.

NOW THEREFORE, the Port Commission of Whitman County does hereby resolve as follows:

Resolution 03-03 is rescinded in its entirety; and

The following guidelines for monetary and other support requests for tourism and recreation development projects in Whitman County are established.

1. The Port is primarily an industrial real estate developer measuring part of its success in terms of new jobs created and new tax bases developed. Although significant to the Port, the recreation and tourism provider aspect of the Port's mission is secondary to industrial and economic development.

2. Internal projects currently operated and supported by the Port of Whitman County satisfy the tourism and promotion aspects of the

Port of Whitman County Comprehensive Plan. The Port of Whitman County has identified three areas of emphasis in the promotion of recreation and tourism in Whitman County but is not limited to:
