## **IT Audit Update**

The Office of the Washington State Auditor (SAO) provided the IT audit plan for testing on the Port's IT systems and will be conducting "interviews" with the Port's IT service provider, Aldridge. This will happen over the next couple of months. The final report will be published, and a public meeting will be held in 5/2021.

#### **NEW BUSINESS:**

**Current Public Meeting Guidance** – this was not discussed much but information was provided in agenda and supportive material.

**COVID-19** The state Department of Health (**DOH**) **releases**, every Friday, the regions' performances to case rates and trends, hospital admissions and ICU occupancy. Municipal Research and Services Center (MRSC, a private nonprofit organization serving local governments in WA State) published a helpful article stating how the new reopening plan affects local government. #### **Engineering Selection Process for Airfield Development Projects**

Port is looking into consultants for airfield development projects and formed a selection board to oversee that the processes conform to regulations.

#### **Resolution 21-04 Integrated Planning Grant (IPG)**

It was approved that the Port is to complete the application in the approximate funding amount of \$200,000 for a **toxic cleanup grant**, the Department of Ecology Integrated Planning Grant (IPG), which is due the last week of January 2021. The Port and WSU have entered into an Access Agreement **for the College Avenue Steam plant** so that the Port can perform an assessment of the Property.

### Employee Manual Update- WA Paid Family Medical Leave Supplemental Benefit

Commission unanimously approved to allow Port employees to use accrued vacation leave, sick leave, compensatory leave, and administrative leave to supplement the benefit paid by Washington Paid Family and Medical Leave.

### **PNWA Mission in WA**

Port will continue to pay membership/sponsorship fee to Pacific Northwest Waterways Association.

**POWBAC Public Safety** Comm Kammerzell spoke of a dilapidated building and rundown vehicles on public property next to POWBAC property as a public hazard and an eye sore. A public complaint to the county has been filed by the Port. Updates for actions will be added to next meeting agenda.

# DRAFT - Port of Whitman County 2021 Legislative Priorities

BROADBAND – The Port of Whitman County supports expanded broadband authority for public organizations. We also request that public port authorities have a seat on the Public Works Trust Fund (PWTF) board. Our expertise in bringing broadband infrastructure to rural communities can be of great benefit to PWTF as the funding for telecommunications projects transfers from the Community Economic Revitalization Board to PWTF.

COMMUNITY ECONOMIC REVITALIZATION BOARD (CERB) – From the construction of Henley Court in Pullman Industrial Park to the Port's fiber-to-the-home project, several of the Port's large-scale developments were made possible by the continued partnership of CERB. The board has been an excellent partner to our community and our Port District. Therefore, we support CERB's legislative request of \$25 million for its core program, \$15 million for rural broadband funding, and codification of broadband authority under RCW 43.160.

WASHINGTON MARITIME BLUE INITIATIVE – The Port is a supporting member of the Washington Maritime Blue Initiative. Maritime Blue is a strategy to ensure Washington State is home to the most sustainable maritime industry in the world by 2050. This program is attractive to industries operating on the Columbia-Snake River System, and the ecological potential is exciting. We request that this fund is made sustainable and continues to build in the future.

TAX INCREMENT FINANCING (TIF) – Along with the Washington Public Ports Association, we support the ability for cities, counties and ports to engage in tax increment financing projects for their local communities. Washington is one of the only states without such a tool currently.

TRANSPORTATION FUNDING – The Port District ultimately benefits from the preservation and maintenance of adequate rail, road and air transportation. Therefore, we support the Washington Public Ports Association's goal of passing a transportation package that balances the need for increased revenue, including through the use of a carbon pricing tool, with increasing spending on maintenance, preservation, multimodal investments, and replacing aging infrastructure.

PCC RAIL FUNDING —The Port supports funding of the Palouse River and Coulee City (PCC) Rail System. (Additional details will be added, pending a response from WSDOT PCC Railway Manager, Bob Westby.)

AVIATION FUNDING – COMMUNITY AVIATION REVITALIZATION PROGRAM (CARB) – This program was established in 2019 to fund revenue-producing capital projects that assist public-use, general aviation airports to become more self-sustainable. As the manager of a general aviation airport, the Port of Whitman Business Air Center, the Port advocates for this program become permanent and receive an additional \$5 million allocation during the 2021-2023 budget cycle.

SMALL WORKS ROSTER THRESHOLDS – Ports were omitted from legislation which increased thresholds for the Small Works Roster procurement tool. A study looking at bid thresholds has recommended ports be allowed to expand their authority, but recent attempts have been unsuccessful.
