Senator Murray Infrastructure Request

"Senator Murray requested infrastructure projects in Washington State for possible upcoming legislation. Port staff worked with Washington State University to fill out the attached form for the **proposed College Avenue Steam Plant project.** If funded, this would complete all phases of the proposed Steam Plant renovation."

"The project entails cleanup up and remediation of petroleum and PCB contamination. Following remediation, the space will be developed to advance a variety of functions, including: 1) lab and education spaces, 2) co-work and clean tech incubation space, and 3) commercial enterprise."

Funding Request:

Cost estimate for cleanup and remediation \$14.875M

Cost estimate for development and buildout \$30.125M

Total \$45M
