Early Learning Services, Monday, April 6 meeting

Alice Schroeder

Sue Kreikemeier from Early Learning Services has graciously agreed to tell us about her organization for our Mon. April 6 meeting, 7:00-9:00 p.m. Early Learning Services also serves Latah County so I have invited members of the Moscow League to join us.

Early Learning Services provides help to disabled and developmentally delayed children as well as help for parents of normal children in both Whitman and Latah Counties. This meeting should be a good follow up on the Washington State Study on *Early Care and Education of Young Children* that we discussed in November, letting us know what is happening in our area. The Washington State League consensus has now been published by the LWVWA State Board based on the response from all the Leagues in the State that participated. I've printed it below. If you would like to review the Study, it is still on the LWVWA website (www.lwvwa.org). Click on the link in the upper right hand side. The first two links on the page that comes up are the unabridged and abridged versions of the study. If you would like to review a printed copy, Sue Armitage has several.

New Position for Early Care and Education of Young Children

The LWVWA believes:

- The quality of the child's early care and education, birth-5, is critical to maximizing the child's future development.
- Parents are a child's first teachers.
- The State of Washington has an important role in assisting parents to ensure that all children have the opportunity to develop to their full potential.

The LWVWA believes the State of Washington should support:

- Home visiting and other educational programs for parents with young children
- Programs for children with special needs
- Increasing access to preschool programs for children age 3-5
- Quality child care programs for children age birth five years
- Expanding the definition of Basic Education to include birth to five years ***
- Improvements to child care programs
- Encouraging public-private partnerships to expand the early care system

The State should marshal a variety of resources to fund these programs, such as federal funding, state funding, public-private partnerships and other financial sources.

Pre-Development Meeting Coming April 22 at 7:30 p.m.!!! Karen Kiessling

Calling all Leaguers to attend the stakeholders meeting at the Pullman Planning Commission on April 22 at 7:30 p.m. in the City Council Chambers.

The Planning Commission has scheduled a special meeting for all interested parties in the topic to discuss the Pullman League's proposed required public meeting for all new development projects. The bones of the ordinance require any developer of new construction of a four-plex or more to be required to hold a public meeting to communicate the plans for the land to members of the public who attend the meeting. The requirements for this meeting are that the developer construct a sign, 4 foot by 4 foot and erect it on the parcel of land to be developed, place ads in the newspaper of record listing the project meeting and where and when it will be held, notify neighboring land owners of the meeting and then hold and record the meeting that takes place. The developer is required to explain the proposed development, answer questions and listen to comments made by members of the public. The developer is not required to change any plans because of the comments of community members. The goal of the meeting is to share information and concerns, suggest answers to potential problems and allow persons who support the proposal to voice that support.

The city, if this proposed ordinance becomes law, is required to create a file in its planning department archives that attests to the holding of the meeting by the developer. The proof of that is the recording of the meeting made at the time, a copy of the ad that appeared in the paper and a copy of the letter of notice. The city has no role other than to see that the pre-development requirements are met before any permits are issued.

We believe that this requirement will further communication and put a halt to the unhappy schisms that have developed in Pullman because information cannot be shared in a public meeting under Washington law after a plat has been filed and permits issued. League believes this is a positive step forward and the ordinance committee of the League asks every League member to be present at the meeting and willing to voice support for this change in city rules.

Special speakers and events: This year Senator Maria Cantwell will be with us as our keynote speaker. You will hear first hand what is happening in that other Washington. And you can meet and enjoy visiting with Senator Cantwell.

There is also an emphasis on a new state League initiative on Civic Engagement. This will be a chance to learn what the state board has in mind for this statewide effort and what projects the Pullman League might want to consider taking on.

There will also be a gala evening on Saturday. The *Washington State League of Women Voters* 2009 Good in Government Awards Gala will be on Saturday from 6:30 to 9:30 p.m. in the Washington State Historic Museum a block away from the Murano Hotel. After the banquet we will all walk to the museum where we will tour the special exhibit *Women's Votes, Women's Voices* which will have docents in period costumes leading tours and taking us on a walk through women's history in Washington State and the nation. Washington State gave women the right to vote in 1910, a decade before the federal government did so – an inspiring walk through history. Also there will be three awards – one to an elected official, one to an organization and one to a member of the media - who all embody the League's high goals for public service. Meet these outstanding citizens of Washington and congratulate them. This is a dessert and wine reception that you will long remember.

Results for NPVC Consensus Questions

Pullman League members had difficulty understanding many of the *National Popular Vote Compact* Consensus questions, as have many other Leagues. Briefly, a majority agreed with statements in favor of the NPVC, while a seriously concerned minority felt a constitutional amendment was the only appropriate approach, so we were unable to reach consensus on questions 1,2,3,4, and 6. Question 5 did not make sense to us and we easily reached consensus to reject it. Consensus was reached on question 7 to agree with both statements:

- a) The NPV Compact will have problems being passed because of the need for congressional consideration and the need for action by so many states.
- b) A constitutional amendment to establish the direct popular election of the President and the abolition of the Electoral College will continue to have problems being passed.

Those in favor of supporting NPVC saw it as a way to keep the issue of the popular election of the president in the public's eye, and as a means to pressure the legislature to proceed with a constitutional amendment.

The consensus report form contains a Statement section, and our report included the following statement, "Once again LWVUS has damaged a good study with very poor consensus questions. This seriously damages the League's reputation. Please get members with experience in writing clear, concise questions to help in formulating consensus questions. Then test them on a small sample of Leagues before using them. Former college professors in our Pullman, WA group would be glad to help."

Current Status of NPVC

On March, 13, the Oregon House and Washington State Senate passed National Popular Vote (NPV) legislation. With bipartisan support, the Oregon house passed the bill 39-19, including 8 Republicans. In New Mexico the State House has also voted to pass NPV legislation.

The NPV bill has been introduced in 47 states with a total of 1,246 state legislators endorsing the legislation. Hawaii, Illinois, Maryland, and New Jersey have already passed the legislation and represent nearly a fifth of the necessary electoral votes to implement NPV.

Observer Report Briefs

Neill Public Library Board meeting, February 18, 2009

Items of interest to the LWV:

- 1) Downtown parking for NPL staff and patrons continues to be an issue, especially since the new director recently received her first parking ticket ("Welcome to Pullman," said the Board). Geraldine de Rooy will talk to John Sherman about such options as parking passes and dedicated spaces.
- 2) Jim Belcher (Adult Services Librarian) presented his quarterly (and 2008) report, including updates on databases, volunteer book deliveries to homebound patrons in facilities, book and knitting club programs, Washington State Library Committee research on downloadable audio access for patrons, plans to host various artists, and ways to display two beautifully crafted train sets on long-term loan to the NPL.
- 3) Geraldine de Rooy will have fifteen minutes at the March 3rd Pullman City Council meeting so members will know who she is and so she can emphasize the NPL's four 2009 goals. Prioritized, they are:
 - a) a regular 20-hour circulation position to stabilize public service;
 - b) restoration of the materials budget to 10% of the total library budget, and by one percent each year so that by 2015, it will be 15% (currently it is 7-8%);
 - c) an on-site, scheduled technical computer position. In 1999, the library had 14 work stations and 1 server; it now has 33 work stations and 5 servers. The position shared with the Whitman County Library District is insufficient.
 - d) a regular young adult/teen librarian to serve a burgeoning demand.

Pullman Arts Commission, March 5, 2009

I went to the meeting tonight and we spent the session folding cards which the Commission will be using for fundraising. PAC was also getting organized for their presentation to the City Council tonight. Items on the agenda are:

Banner approval

- 1. Establish a permanent "home" city department for the Pullman Arts Commission (Parks & Recreation, Public Works or Planning)
- 2. Incorporate art and the procuring of art into the city's long-term overall plan.

- 3. Establish the Pullman Arts Commission as the umbrella organization responsible for all proposed artistic changes, additions or modifications within the City of Pullman.
- 4. Incorporate a distinctive unifying expression or "branding" of Pullman.
- 5. Continue creating opportunities for the arts to thrive in Pullman.

Results should be in the City Council minutes.

League of Women Voters of Pullman Positions For 2009-2011 Bienniun

1. **Whitman County Health Services**: Support for a public health program for Whitman County which promotes the physical and mental health of all residents of the county. *Action: Unit or public meetings on the problem of recruiting doctors (Resource, Dr. Duffy) and establishing a strong rehabilitation center in Pullman (Resource, Scott Adams).*

- 2. **Environmental Quality**: Support of policies and procedures which promote coordinated planning and method of enforcement for the conservation and development of land. Support of policies to promote coordinated planning and implementation of solid waste management procedures which conserve natural resources, are ecologically sound, and aesthetically pleasing. Support of policies to establish city-wide curbside recycling and composting, to maintain a Recycling Center, to hire a recycling coordinator, to encourage procurement of recyclable materials, and development of markets for recyclable materials. *Action to keep recycling going by establishing a committee to examine the current problem and possible solutions*.
- 3. **Whitman County Transportation**: Support of a system of transportation for the Pullman area which will adequately serve all segments of the population. *Action to support our bus and dialaride system in the face of budget cuts*.
- 4. **City and Regional Planning**: Support of principles of planning, subdivisions and zoning. Support of more restrictions on developments for both contractors and private land owners. Support the principle of making land use decisions through a process that requires both a Planning Commission and City Council or County Commissioners. Support of growth within carefully defined areas for commerce and light industry. Support of annual review by the City Council of a Capital Improvement Program for the City. Additional consensus on development in 2002-2003 study. *Action: Continue to work for the adoption of the pre-development community meeting ordinance*.
- 5. **Local Government Budget and Finance**: Support (1) tax measures necessary to maintain an adequate level of financial support for Pullman City Government, (2) long-range Capital Improvement Plan for the City of Pullman, (3) finance implementation of long-range capital improvement. *Monitor*
- 6. **Schools**: Support of measures for a school program adequately financed by the State Basic Education Act. Support of special levies for specific purposes unhampered by a levy lid. Support of the following criteria for schools: (1) Given the present economic constraints of the levy lid law, basic education funding and fluctuating enrollment, it is important to have quality instructional programming and low student teacher ratio. (2) Energy efficiency (fuel & transportation) is an important criteria in considering use or lack of use of a building. (3) In any major redistribution of students, the maintaining of small neighborhood clusters of children should be considered. (4) Complete financial estimates of each option should be made available when considering changes in the use of facilities. *Action: Unit or public meeting on the WASL replacement test(s). Invite the new superintendent of Public Education, possibly working through the Pullman Superintendent's office.*
- 7. **City Government**: Support of the principle of separation of administrative and policy-making functions. *Monitor*
- 8. **Library Services**: Support of (1) a more equitable relationship of library employees compared to other city employees. (2) Additional sources of funding and any expansion to maintain at least the present level of services, (3) cooperative relationships with other area libraries while

9. maintaining local autonomy. *Action: invite the new director to speak at a unit meeting; then review our positions*.
