Successful Back to League Potluck and Basics

The Pullman League opened the new program year with a Back to League potluck dinner at Janet Kendall's home in beautiful early September Palouse weather. After the most delicious meal and lots of getting re-acquainted after the summer hiatus, members were treated to an introduction to League Basics for new members and a useful review for experienced members.

Karen Kiessling addressed important understandings for all members: only the President (or an appointed representative) speaks for League ; the League is non-partisan—no individual candidates are supported or opposed and we speak only to issues the League has studied and upon which we have a position. June Crawford cited opportunities for involvement in League activities, especially the Observer Corps. Deb Olson emphasized the importance of Voter Service, our most visible community activity and the many options to be part of it. Shelley Jones cited the rewards of League leadership roles, both personally and professionally. Paul Spencer demonstrated the League website. Lenna Harding closed the program with personal views of our local League history since she "grew up with it". Thanks to these members and their messages for the reminder that League remains the most trusted and respected political organization in the nation.

Report on The Forum on Open Government Karen Kiessling, Chair, Committee for Open Meetings Act Forum

The lead story at the top of the front page of the Moscow Pullman Daily News on Thursday, September 26th, was the forum held the evening before on the open meetings laws of the state of Washington. It was a League forum providing a panel of experts from the Coalition for Open Government and was held at the McGregor Company Training Center to the west of Colfax.

The League provided a service to elected and appointed officials and a good number of them from the communities in the county were there. We had port commissioners, county commissioner, mayors, staff members and city council members. The audience count varied but was in excess of 50 participants and the information a good education or solid reminder of the strong laws that protect the rights of citizens to know what their representatives are doing and how they are making the decisions they do. We may not agree with the decision but we are guaranteed the right to know how it was arrived at. There was significant discussion of public records requests which all jurisdictions have to deal with and some solutions for keeping those requests within the bounds of the time staff can devote to it. That was perhaps the most tangible reward for those attending.

Many Leaguers helped in various ways on this meeting and we are very grateful for their work.

National Voter Registration Day Deb Olson

National Voter Registration Day was September 24th. My thanks to the League volunteers who helped us this year: Liz and Austin Wilmerding, Anne Lewis and Francy Bose at Neill Public Library, Paul Spencer at Rosaeur's in Colfax and Karen Kiessling at Dissmores. We didn't get as many takers as we would wish (only five people registered on paper or electronically but several more took the registration form with them). Not too bad in an off election year. I hope to host another registration drive in the late spring at Pullman High school, so let me know if you are interested.

LWVWA Has No Position on Initiatives I-522 and I-517

- I-522: Requires labeling on products that include GMO's and is an issue that is being studied at the LWVUS level. Our existing open government positions do not cover labeling. LWVWA can not support or oppose this initiative because we have no positions that cover those areas closely enough.
- I-517: This is the Initiative about Initiatives. "The LWVWA Board felt that our positions supporting initiative processes could lead to a support decision, but our position on upholding the constitution and free speech rights would mitigate against the initiative. Neither position was completely on point and so the Board felt that no position should be taken."

LWVWA Information on Two Upcoming Initiatives

There are two initiatives concerning gun control currently gathering signatures. Signatures for both measures are due to the state Legislature on Jan 3, 2014. If you have any questions or comments about LWVWA's role you can contact <u>kathysakahara@gmail.com</u>.

- I-594: LWVWA has endorsed Initiative 594 regarding background checks on gun purchases. The League encourages LWV members to participate in the campaign, including the collection of signatures. If you want to be part of this effort, please visit <u>www.lwvwa.org</u> to sign up and order petitions from the I-594 campaign. LWVWA has joined the Washington Alliance for Gun Responsibility and encourages local Leagues to join the alliance as well.
- I-591: LWVWA opposes Initiative 591 which prohibits additional background checks on gun purchases.

Preparing For the Agricultural Consensus Meeting Joan Folwell, local Ag Committee chair

The Agricultural Update will focus "narrowly" on: 1) current technology issues in agricultural including genetically modified organisms (GMOs), herbicides, pesticides, agricultural water pollution, water technology, antibiotics in livestock, and accurate food labeling; and 2) current agricultural finance issues including consolidation of agricultural industries, crop subsidies and the federal agricultural regulatory process. Phew!

The modifier "narrowly" is an understatement. The national Agricultural Update Committee has made this recommendation to help local Leagues be better equipped to answer consensus questions (which have not yet been developed). "The update is complex and involves understanding issues that impact our food supply: 1) the technologies used in agriculture, 2) the interactions of farmers, suppliers, processors and consumers , 3) the role of government in regulating and financially supporting the food industry, and 4) how natural processes (often related to climate and weather) affect practices and decision-making. It is the committee's recommendation that Leaguers should develop a general understanding of agriculture within their own state, so that they can then view the system as it relates throughout the country and the global market."

To educate our members on so many topics is an enormous task and only parts of it may be accomplished, but the journey will be interesting! To get you started, there is a lot of information and many links on the national website under the Agricultural Update Forum. This site also keeps you abreast of what the national committee is intending. You have to register as a member to access the website. (Note: I had not done so and the registration process would not allow me to confirm my email address; I sent a note to the webmaster stating the problem and my registration was accepted within a few days.) I am planning on peppering some of the Brown Bag Meetings with ag topics. Having read the topics, let me know which ones particularly interest you; contact me at rjfolwell@pullman.com or 332-3946. Please take every opportunity to read related articles as you come across them. A good start is the Northwest Farm and Ranch issue that recently appeared in the Daily News and Lewiston Tribune on September 30. It included a very balanced argument of both the pros and cons of GMO food labeling and several other interesting articles. The evening program on the Agricultural Update scheduled for November has been deferred until our February meeting. I will do my best to prepare this League to give an educated response to the consensus questions. Your assignment is to read, read, read!

The recent reduction in the Food Stamp and WIC programs means more people lean on our community's resources. The LWV in Pullman can help in two ways. First, if you plan to attend a board meeting or brown bag lunch discussion, please bring something to share with others in our community. Liz Wilmerding or June Crawford will collect all donations and get them to the Food Bank. Secondly, we can organize a food drive this fall or next spring to help fill the shelves. Look in future VOTER issues for more information on how you can help! Items needed: A monetary donation to the CAC is always welcome. Direct general donations can go on the shelves immediately. Here are the things the CAC welcomes:

Food items: Peanut butter, jelly, rice, pasta, beans, canned/frozen meat, canned fruit and vegetables, tomato products (sauce, paste, diced, whole, etc.), pancake mix & syrup, sugar, flour, oil, breakfast cereal, mac & cheese, boxed dinners (i.e., Hamburger Helper), etc.

2nd Harvest/Backyard Harvest: extras from your garden or fruit trees that have a couple of days' unrefrigerated shelf life in them.

Non-food items not covered by Food Stamps: toilet paper, paper towel, dish soap, laundry soap, toothpaste & toothbrushes (a place to put all your extra dentist gifts!), personal hygiene products (shampoo, soap, razors, shaving cream, feminine hygiene), baby food, diapers of all sizes.

Large non-consumables: blankets, baby clothes & supplies, winter coats & hats. Please make sure things are clean and only gently used or are new.

CURRENT NEEDS (9/19): breakfast cereal, box dinners, mac & cheese, canned fruit, tomato products.
