## Political Forum Report Deb Olson

We held only one candidates & issues forum this October. I had to cancel the Initiative Forum scheduled for October 19th due to the difficulty in finding speakers on the initiatives. The forum on October  $20^{\text{th}}$  was held with the two candidates for State Legislature, Mary Dye and Jennifer Goulet, and two Initiatives: I-735 – a proposed amendment to the constitution, and I-732 – a proposed carbon tax. The forum was well attended and many questions were submitted and answered.

## November's Monday Meeting on Food Security Mary Collins

The November program consisted of a panel of folks working for organizations that contribute to food security in Whitman County. Following a brief overview of the LWV of Pullman's findings related to food security presented by Mary Collins, the panel presented information on innovative programs they are currently working on. These included expansion of the local gardens program to several small towns in the county by Back Yard Harvest, a teaching and demonstration effort and kitchen at the Community Action Center, Food Recovery work being led by the Center for Civic Engagement at WSU, and the formation of a Food Coalition led by the Council on Aging in Colfax. All of these groups are actually collaborating on these efforts which promise to promote greater self sufficiency, better use of resources, and healthier diets.

# **Brown Bag Meetings Reports**

#### October 20: County Commissioners Karen Kiessling

All three Whitman County Commissioners attended the brown bag meeting of League held in the Congregational Church the third Thursday in October.

Commissioners Largent, Swannock and Kinzer stated their pleasure at meeting with the League each fall to start talking about the new year, the budget process and specific issues of the town and county. This year the topic of considerable interest was weeds in the county roads and along property lines, especially those considered poisonous to humans or of danger to crops in the area. The enforcement of the removal of such weeds is hampered by small staff and inadequate support by landowners to take care of their own weeds. Leaguer Joan Folwell asked the Commissioners to consider placing a weed assessment before the voters but they unanimously replied that they would not do so unless the weed board assumed responsibility for selling the ballot issue to the voters. There the issue stands.

Another topic they were interested in mentioning is that the Auditor has announced she is not running for re-election and any interested in taking on the job should start planning to run at this time. Elections are close to the hearts of the League and election issues and errors have been a pattern over several years. A strong leader is sought and all were urged to begin thinking of competent people and asking them to consider public service.

#### November 17: Tony Bean, Pullman Airport Manager Deb Olson

Tony Bean, Pullman Airport Manager, presented an update on the airport realignment project. This program was well attended (18 people) by both Leaguers and the public. Tony explained again why this project is needed. The taxi way and runway are too close together and the runway heads straight toward Moscow Mountain; these problems need to be fixed or we lose air service. The realignment will fix these as well as increase the length of runway to accommodate 737's and provide all weather landing & lighting. The new approach will allow planes to land with 300 ft. altitude and 1 mile visibility. New snow removal equipment has already been purchased.

All negotiations with private property owners are complete. Negotiations are ongoing with WSU, using the Federal system – Uniform Relocation Action – which formalizes negotiations and conduct of them.

As anyone driving down airport road can see, lots of earth moving is taking place. Topsoil is being stripped down to the clay and saved to re-contour the topography. The October rains slowed this down and work on the creek relocation has started. The creek is being dug down to bedrock then covered with a 6' by 8' concrete box and diverted around the airport to the south. The creek will reconnect to the original channel at the east end of the runway and be open to handle flood events. The Avista Power line relocation will also be complete by the end of the year.

One interesting tidbit is that the current approach is privately owned by Alaska. In the future this approach may be opened to other airlines with FAA approval allowing other airlines to come to Pullman. Currently Alaska uses 70-90 seat planes that are almost always full. The 737's have a seating capacity of 150-180. Passenger use of the airport for 2016 is estimated to be greater than 60,000. Another interesting fact is that the Pullman airport is one of only a few airports its size that has a body scanner.

Lots of questions were asked concerning the terminal and parking. A section of land is earmarked for a new terminal and parking west of the current terminal.

## Observer Corps Judy Stone

The Observer Corps is composed of members observing various public agencies. The monthly calendar of public meetings and the observers assigned to them is available on our website on the home page. Check it out <u>here</u> and see if there is a meeting you would like to attend.

Excerpts highlighting items of particular interest to League from two of the recent Observer Corps reports are given below.

#### Pullman School District Board Meeting – October 26, 2016 Observer: Dawn Baerlocher

Michael Church came and thanked Dr. Maxwell for his efforts in working towards agreement on the Collective Bargaining Agreement between the school district and teachers. The Bargaining Agreement was approved by 99% of teachers in August. Mr. Church said that he appreciated Dr. Maxwell's willingness to work together on the agreement.

The Jefferson PTA earned \$21,000 in the "Dive In" Fundraiser.

PHS Construction is moving rapidly inside...a little slow outside due to record rain fall this month. The new theater will be named the Dana Cleveland Theater (this was the name of the previous theater). The new Community and Board Room at the High School will be named the Paul Sturm Room. A scholarship is being proposed in Memory of Noah Evermann.

Recommended school calendars were discussed for 2017-2018 and 2018-2019.

Current Full Time Enrollment (FTE) is 2,792, budget of 2,740 FTE

Members do their homework before coming to the meetings. Mrs. Susan Weed discussed a committee she met with in Fife for the OSPI (Office of the Superintendent of Public Instruction) earlier this week. The meeting was on Construction procedures etc. What struck me is that so many of our administrators and Board Members do so much outside of showing up to Board meetings. They are a special group of people who appear to really put kids first. Refreshing.

#### Pullman Regional Hospital Board Meeting – November 2, 1026 Observer: Judy Stone

A public hearing on the proposed 2017 budget had been advertised prior to this meeting. Only a *Daily News* reporter attended and he was given materials that the rest of the Commission had. You may have seen the article he wrote the next day. I thought it was very accurate. The proposed budget was passed.

Bids for the surgery expansion project were discussed in detail. Scott Adams, CEO and Steve Febus, CFO discussed the other building projects planned for the next few years. These have previously been put on a tentative timeline and Adams explained that funding and sustainability concerns might need to move projects around within that timeline or modify them. He asked the Commissioners to agree to that flexibility and they did. The primary focus in the 2017 budget is to finalize several outstanding projects including the OR remodel, Same Day Services expansion, expansion of the Clinic Network

(Pediatrics and Behavioral Health), support of primary care and expansion of hospitalist services.

Psychiatric Interagency Collaboration apparently now exists between Palouse River Counseling, WSU Health and Wellness, WSU Counseling Services, Pullman Regional Hospital Emergency Department, Palouse Psychiatry, and local law enforcement. There was no explanation about how this collaboration works.

The Whitman County Health Network is preparing an application to HRSA for funding to develop a program that will integrate primary care services along with behavioral health medicine through telemedicine technology.

Financial Report: The District as a whole (hospital plus their LLCs) experienced a consolidated excess of revenue over expenses YTD of \$299,000 compared to last year's YTD \$1,121,000. Yes, the commas are in the right places.

There is still no applicant to fill the Commission vacancy and the deadline is around the third week of December. If there are no applicants the County Commissioners will appoint someone.
