# Judge Gary Libey- Karen Kiessling

The new year of brown bag presentations began on Tuesday, September 15, with a zoom meeting that was handled magnificently by our tech wizard Helen Catanese. Karen Kiessling hosted the gathering and was

delighted that on this third attempt, his Honor, Judge Gary Libey, was able to meet with us -- all safely distanced -- to discuss the workings of the Whitman County Superior Court.

Judge Libey is running unopposed for a new term on the Superior Court of Whitman County. He said he was honored that when his predecessor, David Frazier, stepped down from the office and an interim appointment was required, he applied for the job, and as no one else requested consideration, he was appointed. He feels that running unopposed means that the law community believes he is doing a good job.

Superior Court forms and procedures were explained, the difference between District Court and Superior Court was also discussed and then the meeting opened for questions from those of us in attendance. It was noted at the beginning that this meeting was recorded and that it is available on the League website.

One question that may be worth exploring is the possibility of establishing a mental health court, along the lines of the drug court that is in place in Whitman County now. Judge Libey assured the audience that he is always interested in ways to make the court function more efficiently and with a better outcome for those who appear there.

Karen Kiessling closed the meeting and thanked the Judge and those attending for their presence.

# Update on COVID-19- Judy Stone

In the September 3<sup>rd</sup> evening meeting conducted on Zoom, Dr. Bronwyn Gunn, WSU Assistant Professor in Virology and Immunology, gave an awesome presentation clearly explaining the novel coronavirus that causes coronavirus disease 2019, or COVID-19. Her data was specific to understanding how this virus causes the illnesses we are experiencing. Troy Henderson, Director of the Whitman County Department of Public Health then detailed the demographics and incidence of COVID positive infection being seen in Whitman County. Although his information was not joyful it did affirm how the Health Department is keeping track of this pandemic for our community.

#### **Business pertaining to League Positions or topics of interest:**

Port of Whitman County Commissioners Meeting took place via Zoom and teleconference. Commissioners and some staff and the special guests were in the office practicing social distancing and wearing masks. Commissioner Kammerzell ran the meeting and called the meeting to order at 10:02 am.

#### **OLD BUSINESS:**

#### **Central Ferry Rail Project**

Ms. Riebold reported that the rail crossing at Central Ferry is complete and is a huge improvement.

# Policy Project- Update for Industrial Development Corporation Resolution No. 186 (3-10-1982)

The Port Attorney reviewed the resolution and statute. He didn't see any reason for the Port to revoke the policy for now. He stated it is unlikely the Port will use the corporation for revenue bonds, but it doesn't hurt us to keep the resolution for now.

#### **Pioneer Ports Meeting Update**

During the last meeting the commissioners wanted to check with the Valley Ports to see if they would host an in-person meeting at a local park. The Valley Ports were not comfortable with this and would like to see a Zoom meeting format. Oct 19, 20, or 21 are being considered for this virtual meeting.

# **Digital Communications Update**

# Economic Development and Value-added Ag Update

Mr. Peterson (University of Idaho economist) gave an executive summary of his newly completed work on the Port Economic Impact Study. There are 4 key county economies in the area. He said that "the Port of Whitman County is arguably the most impactful economic development agency in the region" with a notable increase in entrepreneurship. Whitman county used to be constrained in the past but "Whitman County is the Industrial leader of the 4-county region."

Brian Kraft, WSU Innovation and Research Engagement, stated that the grant proposal they were working on in March 2020 was not funded. The Port signed a letter of support for this project. Brian spoke of developing strategies and opportunities that he has been working on this summer. I did not hear any of this since they were having technical difficulties.

Tom Handy has been a supporter of micro-malting and use of different crops grown in the region for his business. Tom is past president of Whitman County Development Association, President of the Pullman Chamber, and has been involved in economic development on the Palouse for decades. Tom is also running for county commissioner this fall. **I did not hear any of his update due to technical difficulties**.

# Schedule Strategic Planning Meeting

# **Port Meeting Minutes**

Staff recommended a transition to action minutes as defined in Roberts Rules of Order, which records only the action outcomes of the meeting and not what was said by its members. Discussion minutes, which are lengthy and may include information which is not essential to the focus of the meeting, is what the port currently uses. Commissioner Kammerzell likes to review the minutes for the details on what was last discussed and prefers to keep it that way or suggested that the meetings be recorded for review when needed. Commissioner Meyer would prefer the action minutes but conceded to keeping the discussion minutes to end discussion.

# Central Ferry Termination Association (CFTA) and Pomeroy Grain – Sale of Assets & Assignment of Lease

Pomeroy Grain Growers is working on purchasing the CFTA infrastructure at Central Ferry. CFTA will be requesting to assign their current lease, which runs through 2040, to Pomeroy Grain Growers in order to complete the sale. A motion was made by Commissioner Meyer and passed for staff to work with both tenants at Central Ferry on the paperwork required to assign the lease and assist completion the sale.
